

TERMS AND CONDITIONS

BACKGROUND:

This agreement applies as between you, the User of this Web Site and ClassifiedQuick which is a trading name for Proactive Selection Limited, the owner(s) of this Web Site. Your agreement to comply with and be bound by these Terms and Conditions is deemed to occur upon your first use of the Web Site. If you do not agree to be bound by these Terms and Conditions, you should stop using the Web Site immediately.

No part of this Web Site is intended to constitute a contractual offer capable of acceptance. Your order constitutes a contractual offer and our acceptance of that offer is deemed to occur upon our sending a dispatch email to you indicating that your order has been fulfilled and is on its way to you.

1. Definitions and Interpretation

In this Agreement the following terms shall have the following meanings:

“Account”	means collectively the personal information, Payment Information and credentials used by Users to access Paid Content and / or any communications System on the Web Site;
“Content”	means any text, graphics, images, audio, video, software, data compilations and any other form of information capable of being stored in a computer that appears on or forms part of this Web Site;
“CQ”	means ClassifiedQuick which is a trading name for Proactive Selection Limited whose registered office is at The Old Stores, 23 High path Road, Guildford, Surrey. CQ also trades from Unit1B, Gwydir Enterprise Centre, 23-35 Gwydir Street, Cambridge, Cambridgeshire, CB1 2LG;
“Service”	means collectively any online facilities, tools, services or information that CQ makes available through the Web Site either now or in the future;
“Services”	means the services available to you through this Web Site, specifically Classified Advertising, Marketing & Promotion;
“Payment Information”	means any details required for the purchase of Services from this Web Site. This includes, but is not limited to, credit / debit card numbers, bank account numbers and sort codes;

- “Purchase Information”** means collectively any orders, invoices, receipts or similar that may be in hard copy or electronic form;
